Agreement overview: This agreement contains the understanding between Danielle Wilborn of Alten Studio Photography and the CLIENT. It supersedes all prior and simultaneous agreements between the parties. Changes or additions to this agreement must be made in writing and signed by all parties. If one provision of this agreement proves unenforceable the rest shall remain valid and enforceable.

Cooperation: The parties agree to cooperation and communication for the best possible results within the definition of this agreement. Danielle Wilborn of Alten Studio Photography is not responsible if key individuals fail to appear or cooperate during photography sessions or for missed images due to restrictions not revealed to Danielle Wilborn of Alten Studio Photography.

Images and Copyright: The images produced by Danielle Wilborn of Alten Studio Photography are protected by Federal Copyright Law (all rights reserved) and may not be reproduced in any manner without Danielle Wilborn of Alten Studio Photography’s explicit consent. Upon purchase of the digital files limited rights to use and publish images of the CLIENT are transferred to the CLIENT including prints for personal use and sharing, announcements and invitations, as well as use for personal blogs, websites, and social networks. The CLIENT may not re-distribute the digital files for any commercial venture without prior compensation to and in agreement with Danielle Wilborn of Alten Studio.

Model Release: The CLIENT hereby grants Danielle Wilborn of Alten Studio Photography the irrevocable and unrestricted right to use and publish images of the CLIENT for editorial, trade and advertising use. The CLIENT hereby releases Danielle Wilborn of Alten Studio Photography from all claims and liability relating to said images.

Limit of Liability: In the unlikely event that the photographer is injured or becomes too ill, or has an extreme emergency that prevents him from photography according to this agreement, Danielle Wilborn of Alten Studio Photography will make every effort to reschedule the event. If for whatever reason this is not possible, responsibility and liability is limited to the return of all payments received for the package purchased. Danielle Wilborn of Alten Studio Photography takes the utmost care with respect to exposure, transportation, and processing of the images. However, in the unlikely event that images have been lost, stolen, or destroyed for reasons within or beyond Danielle Wilborn of Alten Studio Photography’s control, Danielle Wilborn of Alten Studio Photography’s liability is limited to the return of all payments received for the portrait package.
